Estimation of ice cost is \$19965.60

Board needs to discuss how we pay for ice going forward.

The cost of the ice was not mentioned in the user agreement meeting with the city. \$50 an hour for ice is undoable in the current structure of the club. The previous agreement of incremental increases proposed last year is more doable.

Julie shared the percentage of total revenue allocated to ice cost from other organizations.

Julie also stated that we have enough to cover cost this year, but we need to create solutions for ice cost going forward.
