New Membership Update

Total members was 67, we are at the same total number, this is pre-season, so good growth.

The idea is to have slow and steady growth going forward.

Coach list was published and two new coaches have yet to get all of their paperwork.

Need approval for an associate member. Motion was moved by Trish and seconded by Jodie and approved.

Total membership might reach 75.

Good amount of coaches to skaters

Doubled amount of pre-season ice.

Trish proposed an increase in coach pay for next year. Increase offer coaches helping ICE Chips and try it free events. \$25 for Lead Coach and \$20 to for coach helpers per half hour (Currently \$20 for the lead coach and \$15 for the coach helpers). It would also increase the pay to \$45 for the lead coach and \$35 for the coach helpers (Currently \$40 for lead coach and \$30 coach helper per event).

Jodie made motion to amend to original motion made by Trish that would have increased by \$5 across the board for lead coach and coach helpers. The new motion Increases the pay to \$30 for Lead Coach and \$20 for coach helpers per half hour and \$50 for lead coach for try it free events and helpers will be \$35 pee event.

New change in coach eligibility (previously coaches could 16 years old) now you have to be 18 years old to be a coach through ISI.

As a club we can make it happen for 16 and 17 year olds. We require liability insurance for all coaches, a 16 year old can access the back door liability insurance through ISI.

Junior instructor certification is available through ISI.

Motion by Trish to approve qualified 16 year olds as a coach for BFSC on a case by case by the board as long as they have met club qualifications

- -Complete a Professional Agreement with the BFSC.
- Subscribe to Personal Liability Insurance and provide proof of such to the BFSC.
- Adhere to the ISI Tenet of Professionalism and Code of Ethics.

These coaches would be able to participate in the club professional reimbursement program.
